
Pedestrian Quick Facts

- ts
- Florida has twice the national average of pedestrian fatalities
- Pedestrian crashes account for 3% of all traffic crashes but result in 20% of traffic fatalities
- 1 in 5 traffic fatalities is a pedestrian
- 7% of pedestrian crashes result in fatalities, whereas only 1% of all traffic crashes result in fatalities
- 1.3 pedestrians are killed every day, almost
 10 pedestrians are killed every week
- 17 pedestrians are injured every day, almost
 120 pedestrians are injured every week

Bicyclist Quick Facts




- 1 in 20 traffic fatalities is a bicyclist
- 92% of bicycle crashes result in injuries, whereas 52% of all traffic crashes result in injuries
- Bicycle crashes account for 2.2% of all traffic crashes and result in 4% of all injuries
- 2.3 bicyclists are killed every week
- 88 bicyclists are injured every week



Florida's Pedestrian and Bicycle Focused Initiative


Pedestrians

Between 2008 and 2012, 2,453 pedestrians died in traffic crashes on Florida roads and highways, and 8,143 were seriously injured. Pedestrian fatalities and serious injuries increased from 2,208 in 2008 to 2,244 in 2012.



Bicyclists

Between 2008 and 2012, 530 bicyclists died in traffic crashes on Florida roads and highways, and 3,792 were seriously injured. Bicycle fatalities and serious injuries have increased from 858 in 2008 to 1,038 in 2012.



Florida's Bicycle/Pedestrian Focused Initiative

In November 2011, FDOT Secretary Ananth Prasad charged District One Secretary Billy Hattaway with the task of championing Florida's Bicycle/Pedestrian Focused Initiative. Secretary Hattaway quickly formed a team and began working towards the goal of increasing awareness and decreasing fatalities of bicyclists and pedestrians in Florida.

The purpose of Florida's Pedestrian and Bicycle Strategic Safety Plan (PBSSP) is to focus funding and resources on the areas that have the greatest opportunity to reduce pedestrian and bicycle fatalities, injuries, and crashes. The PBSSP is designed to provide a comprehensive strategy to address pedestrian and bicycle safety issues by identifying goals, objectives, strategies, tasks, and performance measures for key program areas including:

- Data, Analysis, and Evaluation
- Driver Education and Licensing
- Highway and Traffic Engineering
- Law Enforcement and Emergency Services
- Communication Program
- Outreach Program
- Legislation, Regulation, and Policy

Many agencies, organizations, and groups have responsibilities and interests in pedestrian and bicycle safety issues. Florida's Pedestrian and Bicycle Safety Coalition was formed to prioritize and implement the strategies identified in the PBSSP. This diverse group represents many agencies and organizations that have a vested interest in pedestrian and bicycle safety in Florida.

Significant Accomplishments

Florida's Bicycle/Pedestrian Focused Initiative Leadership Team

- Conducted an Assessment of Pedestrian Safety in Florida. (January 2012)
- Partnered with the National Highway Traffic Safety Administration to conduct "Pedestrian 101" training for all focused initiative team members. (May 2012)
