The City of Fort Lauderdale is pleased to provide you with the 2015 Water Quality Report to inform you about the water we deliver to you every day. This report contains information about the City's water source, water supply, the treatment process, and the contents of your drinking water. The City of Fort Lauderdale routinely monitors for contaminants in your drinking water according to federal and state laws, rules, and regulations. Except where indicated otherwise, this report is based on the results of our monitoring for the period of January 1, 2015 to December 31, 2015. Data obtained before January 1, 2015 and presented in this report are from the most recent testing done in accordance with laws, rules, and regulations.

### O DRINKING WATER SOURCES AND CONTAMINANTS

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

MICROBIAL CONTAMINANTS, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

INORGANIC CONTAMINANTS, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

PESTICIDES AND HERBICIDES, which may come from a variety of sources such as agriculture, stormwater runoff, and residential uses.

ORGANIC CHEMICAL CONTAMINANTS, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.

RADIOACTIVE CONTAMINANTS, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. 
#### **HEALTH INFORMATION**

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. ## 2015 WATER QUALITY TABLE AND INFORMATION



The EPA requires the City of Fort Lauderdale to provide an annual report on laboratory tests taken on its drinking water. The 2015 Water Quality Table on the following page provides a summary of those test results.

#### WATER OUALITY TABLE DEFINITIONS

ACTION LEVEL (AL) is the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

MAXIMUM CONTAMINANT LEVEL (MCL) is the highest levelof a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MAXIMUM CONTAMINANT LEVEL GOAL (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MAXIMUM RESIDUAL DISINFECTANT LEVEL (MRDL) is the highest level of a disinfectant allowed in drinking water. There is convincing evidence that the addition of a disinfectant is necessary for control of microbial contaminants.

#### MAXIMUM RESIDUAL DISINFECTANT LEVEL GOAL (MRDLG)

is the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

NOT DETECTED (ND) indicates that the substance was not found by laboratory analysis.

PARTS PER BILLION (PPB) is one part by weight of analyte to 1 billion parts by weight of the water sample.

PARTS PER MILLION (PPM) is one part by weight of analyte to 1 million parts by weight of the water sample.

PICOCURIES PER LITER (PCI/L) is a measure of radioactivity in water.

#### **ABOUT LEAD**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Fort Lauderdale is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.

When your water has been sitting for several hours, you can minimize your potential for lead exposure by flushing your tap for 30 seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. #### SOURCE WATER ASSESSMENT

In 2015 the Florida Department of Environmental Protection performed a Source Water Assessment on our system. The assessment was conducted to provide information about any potential sources of contamination in the vicinity of our wells. There is one potential source of contamination identified for this system with moderate susceptibility level. A Sanitary Survey of the Public Water System was conducted by the FDEP in November 2015. The following significant deficiencies were noted in the Prospect Wellfield: Specifically, improper seals on wells 26, 27, 28, 31, 33, 35, 36, 38, 42, 45, 46, 47, and 53. Corrective actions were completed within 30 days of notification.

#### MICROBIOLOGICAL CONTAMINANTS

Total coliform bacteria: Highest Monthly Number is the highest monthly number of positive samples for systems collecting fewer than 40 samples per month. Highest Monthly Percentage is the highest monthly percentage of positive samples for systems collecting at least 40 samples per month.

\*On August 8, 2015, City of Fort Lauderdale staff sampled source Well #47 in the Prospect Wellfield for the fecal-indicator, E. coli. On August 9, 2015 Well #47 tested positive for E. coli. Well #47 was reconditioned in accordance with AWWA guidelines and passed twice daily testing for E. coli over a five day period in accordance with state regulations between August 17 to August 21, 2015. Well #47 was returned to service on September 9, 2015. It should be noted that a raw composite of all wells is taken daily along with a daily finished water sample leaving the Water Treatment Plant and all of these samples were negative for E. coli. Routine monitoring in the distribution system were also negative for E. coli.

\*Health Effects: Fecal coliforms and E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Microbes in these wastes can cause short-term effects, such as diarrhea, cramps, nausea, headaches, or other symptoms. They may pose a special health risk for infants, young children, some of the elderly, and people with severely compromised immune systems.

### FROM SOURCE TO TAP: WHERE YOUR DRINKING WATER COMES FROM

Where does Fort Lauderdale's water come from and how does it get from its source to the tap? The City of Fort Lauderdale pumps water from wells that draw it from the Biscayne Aquifer, which is an underground water supply and the sole source of the City's drinking water.

Before it reaches the faucet, the water travels from the Biscayne Aquifer to one of the City's two treatment plants – Fiveash, a lime softening plant, or Peele Dixie, a nanofiltration membrane plant.

At the treatment plants, the water is softened, fluoridated, filtered, aerated, and cleaned to

remove naturally occurring minerals, particles, and dissolved gasses. The water is then disinfected with chloramines and fluoride is added to promote healthy teeth.


BISCAYNE AQUIFER

Once the treatment process is complete, the finished water is then pumped to storage tanks or to the distribution system for use.

Throughout the year, Fort Lauderdale's water is routinely monitored and tested to ensure customers receive high quality drinking water that meets all federal, state, and local regulations.
