The Florida Department of Transportation (FDOT), District Four, will conduct a Construction Open House regarding the improvements on SR 811 / NE 4 Avenue / Wilton Drive in Fort Lauderdale and Wilton Manors. This will be conducted as an informal open house beginning at 5 p.m. Representatives will be available to provide pertinent information and answer questions. Construction plans will be available for public viewing.

The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally-mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward. PROJECT IMPROVEMENTS

- Removing old asphalt and resurfacing the roadway
- Upgrading signs and pavement markings
- Adding a buffered bike lane in each direction
- Widening sidewalks, upgrading pedestrian signals and modifying pedestrian curb ramps to meet ADA requirements
- Upgrading roadway and pedestrian lighting
- Installing new drainage structures and upgrading the existing drainage system

TRAFFIC IMPACT

- Lane closures will not be allowed between 6 a.m. and 9 a.m. or between 4 p.m. and 7 p.m. from Sunrise Boulevard to the South Fork of the Middle River.
- Pedestrian access will be maintained on at least one side of the street at all times.
- Additional information about lane closures will be provided in the weekly traffic report distributed by FDOT.
