



Approved FY2021 Budget

Last week, the Commission passed our FY2021 budget that goes into effect on October 1, 2020. The FY2021 total budget of \$847,858,597 maintained the current millage rate of 4.1193 and annual Fire Assessment rate of \$311 per single family residential unit. This budget completely eliminated the Return on Investment transfers from the Water and Sewer fund to General Operating, fulfilling our promise to discontinue raiding the water and fund for other purposes. This represents a reduction of \$20.4 million (or 100% since the FY2018 Adopted Budget) in revenue to the General Fund. The budget is structurally balanced with ongoing revenues equal to ongoing expenses and does not utilize Fund Balance dollars or one-time budget balancing techniques. The budget reflects funding to move our top priorities forward including: Homelessness and Housing Opportunities; Infrastructure; Comprehensive Plan and Downtown Master Plan Implementation; Water and Waterway Quality; Transportation and Traffic; and Resiliency. In addition, the City Commission approved a resolution adopting the FY2021 Non-Ad Valorem Stormwater Assessment to fund the construction, reconstruction, repair, improvement, and extension of stormwater management systems within the City of Fort Lauderdale including the District 2 priority neighborhoods of Progresso Village and

Victoria Park. The assessment methodology is based on equitably recovering costs in proportion to the benefit that each property receives from the stormwater system. The stormwater utility rate structure considers total square footage, trips generated by various property types, and the benefit that free, passable roads bring to each property. This hybrid rate methodology was presented to the Infrastructure Task Force and the Council of Fort Lauderdale Civic Associations, both of which were in support of the program. **Beginning October 1, 2020, the stormwater rate will be billed annually on the property tax bill instead of monthly on the utility bill.** The stormwater management fee will appear as a stormwater assessment in the Non-Ad Valorem Taxes section of the property tax bill. The budget also included the Five-Year Community Investment Plan (CIP), a planning document that sets forth the City's capital improvement objectives to ensure that municipal facilities and infrastructure improvements are appropriate and adequate to serve the needs of our neighbors. The Five-Year CIP will appropriate more than \$190 million in Fiscal Year 2021 for a variety of capital improvement projects including infrastructure improvements to water, sewer, and stormwater systems; replacing seawalls and bridges; electrical and lighting upgrades; street and roadway enhancements; and facility upgrades. While we are full speed-ahead with many infrastructure improvements like our sewer mains and stormwater system, there are still other substantial infrastructure improvements to tackle. The 1954 Fiveash Water Treatment Plant is falling apart and over a third of our watermains are over 60 years old. At our last Commission Meeting, consultants provided a presentation with a range of financing options available for rebuilding the Fiveash Plant. The presentation reviewed various types of Public/Private Partnerships including Public Ownership, Public Ownership/Private Management, Concession Lease, and Private Ownership (Sale), along with the advantages and challenges presented by each option. Commission Meeting Actions

I am pleased to report on the following approved District II Commission Actions from this past Tuesday:

Streetscape Improvements for Downtown Mobility Hub

The City Commission approved an amendment to the Revocable License Agreement with Broward County for the installation of streetscape improvements as part of the Downtown Mobility Hub. The Downtown Mobility Hub Streetscape Improvement Project provides infrastructure improvements within a multi-block area that will improve mobility and connect people to various transportation choices such as Brightline, Broward County Transit bus service, shuttle service to the Tri-Rail station, and the Sun Trolley Community Bus Service. The agreement will allow sidewalks and curb improvements to be installed on property owned by Broward County. The project is slated for completion at the end of the year. Landscape Improvements on A1A

The City Commission approved an agreement with the Florida Department of Transportation (FDOT) to construct landscape improvements on State Road A1A from Seabreeze Boulevard to Alhambra Street as the next phase of the City of Fort Lauderdale Beach Streetscape Improvement Project. New Planning and Zoning Fee Schedule

The City Commission adopted a new Planning and Zoning Fee Schedule with the exception of several fees associated with historic preservation. The fee schedule was developed after an in-depth study was completed by the City's Department of Sustainable Development with assistance from consulting firm PMG Associates, Inc. to analyze and update the current fees with the goal of recovering the City's full cost for providing services. I have asked staff to review the fees that impact the Sailboat Bend neighborhood and requested that they be reduced to zero as I feel strongly that owners should not have to pay a fee when mandated to appear before the HPB either in-person or administratively. My goal is provide incentives and relief for owners of historically designated properties. For details, visit <u>bit.ly/33urQew</u>.

Rezoning Request for 3000 Alhambra Development

As a result of more than two years of dialogue between the developer and the Central Beach Alliance, the City Commission approved a request to rezone 2.27 acres of land in Fort Lauderdale's central beach area (located east of the Intracoastal Waterway between Alhambra Street and Sebastian Street) from A-1-A Beachfront Area District (ABA) to Planned Development District (PDD). The City Commission also approved the associated site plan submitted by KT Seabreeze Atlantic, LP. The applicant is proposing to construct two 26-story towers with 215 residential units, 5,150 square-feet of ground floor retail and restaurant space, and 120 public parking spaces at 3000 Alhambra Street. King Tides and High Tides in our Community

With seven miles of shoreline, 300 miles of canal coastline, a flat topography, and shallow, porous aquifer, Fort Lauderdale is vulnerable to the effects of climate change and sea level rise. Flooding in low-lying areas is more likely when the close proximity of the moon, higher than average tides called King Tides, rising sea levels, and inclement weather conditions combine to exacerbate flooding risks. Rainfall and wind strength and direction can have a significant impact on the height of the tides causing them to come in higher or lower than predicted. Also note that high water tables (groundwater level) due to rain events can raise the probability of localized flooding.

- November 13 18

Voting Information

Deadline to Register

The registration deadline to vote in the General Election is October 5.

Vote-by-Mail Ballot 'Send' Deadline

For absent stateside and overseas uniformed service member and overseas civilian voters (also known as UOCAVA voters), Supervisors of Elections send the ballots no later than 45 days before an election. The send period for the 2020 General Election is September 19.

For domestic voters, Supervisors of Elections send the ballots during a 7-day window between 40 and 33 days before an election. The send period for the 2020 General Election is September 24 - October 1.

The last day to request a mail-in ballot is October 24.

Early Voting Dates & Times

October 19 Through November 1 7:00 a.m. to 7:00 p.m.

You can drop off your mail-in ballot from October 19 - November 1 at any early voting location.

Election Day - November 3 7:00 a.m. to 7:00 p.m.

Completed mail-in ballots can be dropped off at early voting sites. They cannot be dropped off at your precinct on Election Day unless you mean to dispose of the ballot and vote in person.

If you plan to mail your ballot, please do so no later than the second week of October to ensure timely delivery and check the status of your ballot at <u>browardsoe.org</u>.

Please note that, according to the Broward Supervisor of Elections office, 3,302 ballots were rejected in the August 18 Primary. 2,923 of those ballots arrived after 7 p.m. on Election Day. Another 288 mail in ballots had no signatures on the envelopes, 76 signatures were signed by someone other than the voter, and 15 did not match the same voter's signature on file.

Census Ends September 30! Take Action Now And Please Share This With All of Your Contacts!

Attention Neighbors! The U.S. Census Bureau is ending all counting efforts for the 2020 census on September 30, a month earlier than previously announced. That means we all need to work together to take action today! Please help the City of Fort Lauderdale be accurately counted in the 2020 Census.

Currently, Fort Lauderdale's response rate is 53.3%, which is more than 10 percentage points behind the current national response rate of 63.8%, and more than 7 percentage points under the current state of Florida response rate of 60.6%.

Counting every neighbor in our City gives us an opportunity to receive our fair share of more than \$1.5 trillion in federal funding for infrastructure, schools, housing, roads, healthcare, and public service programs. An accurate census count also provides critical funding for hospitals, disaster recovery, and emergency readiness for pandemics like COVID-19.


