#### **November 2020 Newsletter**



Dear Neighbor,

We have experienced many water-related concerns this past year from the sewer main breaks almost a year ago to our most recent flooding from extreme rainfall. With each event, the City continues to take swift and meaningful action through the expedited redundant sewer force main project to investing \$200M in our most flood-impacted neighborhoods which include District 2's Progresso Village and Victoria Park. Much of this work is long overdue and necessary to improve our

water infrastructure across the City.

Before these water events, residents raised concerns about testing of the waterways and this was brought to the forefront this past year. During our last budget hearings, I advocated that we include \$100,000 for independent water testing at ten recreational sites throughout the City. We recently signed an agreement with Miami Waterkeeper, a South Florida-based non-profit and leader in clean water advocacy, to perform weekly water quality tests throughout the City and results will be posted online at <a href="https://www.theswimguide.org">www.theswimguide.org</a>, using an easy-to-understand method. Weekly reports will follow the same format and criteria scheme used by the Florida Healthy Beaches program to assess recreational water quality. There are a variety of bacterial factors that impact our 165 miles of waterways including wildlife, stormwater runoff, pet waste, landscaping debris, homeless populations, septic tanks and boat discharges. Our waterways are vital to our marine industry and our iconic water activities and this independent water testing will provide more transparency and insight in keeping our waterways clean and safe.

#### IMPROVING OUR WATERWAYS

#### Miami Waterkeeper Water Quality Monitoring

As Fort Lauderdale continues a path of building a healthy community and improving water quality, the City recently committed to a water quality monitoring service agreement with Miami Waterkeeper, a South Florida-based non-profit and leader in clean water advocacy. The agreement requires Miami Waterkeeper to perform weekly water quality testing across key waterway recreational areas over a 12-month period. Weekly results will be posted online at <a href="https://www.theswimguide.org">www.theswimguide.org</a> using an easy-to-understand method. Results may also be downloaded via the programs' mobile device app.



Weekly reports will follow the same format and criteria scheme used by the Florida Healthy Beaches program to assess recreations water quality (<a href="www.floridahealth.gov/environmental-health/beach-water-quality/index.html">water-quality/index.html</a>):



Miami Waterkeeper uses the described criteria as a reporting standard to gauge risk of exposure to water while swimming and recreating. Weekly sampling is expected to take place at each of the City's designated Watersports Activity Areas and six additional sites on other water bodies used for recreational purposes. Samplies will be collected and processed each Tuesday and posted online the very next day. Sampling is expected to begin in December 2020.

- 1. Sand Bar (Sampled from SE 10 Street)
- 2. Lake Sylvia (Sampled from parking area at the end of Harbor Beach Parkway)
- 3. Middle River (Sampled at George English Park kayak launch)
- 4. Sunrise Bay (Sampled from Birch State Park)
- 5. Sweeting Park (North Fork of the New River)
- 6. Coontie Hatchee Park (South Fork of the New River)
- 7. Tarpon River (Sampled at SE 9 Avenue Bridge or from an alternative (ALT) sampling location at South Rio Vista Boulevard)
- Himmarshee Canal (Sampled at Las Olas Boulevard)
- 9. Royal Palm Drive (Sampled at Las Olas Boulevard)
- 10. Annie Beck Park (Sampled at the waterway stairs)

# City to Offer Small Business, Non-Profit and Residential Grants Through CARES Act Assistance Programs

The City of Fort Lauderdale is committed to helping our residents and businesses throughout the COVID-19 pandemic. The City recognizes that this pandemic has caused extreme hardship for many of the City's residents and business and continues to leverage resources and partnerships to assist those in need.



The City, in partnership with Broward County, is receiving nearly \$4 million of the \$30 million in federal funding the Board of County Commissioners allocated to support the Broward County CARES Act Small Business and Non-Profit Assistance Grant Program. The City will be awarding a total of \$2.3 million in small business grants through the program, which is being administered by the County's Office of Economic and Small Business Development.

Eligible Fort Lauderdale businesses with 20 employees or less and non-profits with 25 employees or less can apply for up to \$5,000, \$10,000 and \$15,000 in one-time grants for costs incurred as a result of the COVID-19 pandemic. These funds are not a loan and do not have to be paid back.

According to Sandy-Michael McDonald, Director of Office of Economic and Small Business Development, "For the profit businesses, priority will be given to small businesses located in six of the County's most economically distressed zip codes and businesses that have not previously received any federal COVID-19-related business assistance funding, such as the Economic Injury Disaster Loan (EIDL), CARES Act Paycheck Protection Program (PPP), or the State of Florida Small Business Emergency Bridge Loan." For non-profits, priority will be given to those that have also not received

prior COVID-19-related financial assistance and have tried to continue providing services during the pandemic.

The application deadline has been extended through December 2nd at 10PM. Interested business owners and non-profits are encouraged to visit the County's website at <a href="mailto:Broward.org/cares">Broward.org/cares</a> to learn more about the grant program, eligibility criteria, application requirements, the selection and award process, and free technical assistance.

#### **Residential Grants**

The City will also be awarding \$1.6 million in residential grants through the Broward CARES Act. The residential component of the CARES Act program is being administered by Broward County's Family Success Centers.

### Free Drive-Thru COVID-19 Testing at Mills Pond Park and Holiday Park

The Florida Department of Health is operating drive-thru COVID-19 testing sites at Fort Lauderdale's Mills Pond Park, located at 2201 NW 9 Avenue, and Holiday Park, located 1150 G. Harold Martin Dr. (US 1 and N.E. 8th Street just south of Sunrise Boulevard inside Holiday Park). Please remember to wear a face covering.




