Our community has been tested like never before through this once in a lifetime pandemic. I am pleased to hear that many residents throughout the City have been able to secure their vaccinations. Bahia Mar

After requesting that the City Commission be given an update and the ability to discuss our most important public land, I was pleased that last week the Commission deliberated on the future of the City-owned Bahia Mar site. The peninsula is home to the Fort Lauderdale International Boat Show and Bahia Mar-Double Tree by Hilton Hotel, located across the street from the Central Beach Basketball Courts on Fort Lauderdale Beach.

For those of you who might not know, the prior City Commission in December of 2017 approved a new site plan with our tenant Rahn Bahia Mar, but kept the 1995 lease intact. The basis for our discussion on March 16 was a tenant-proposed Amended Master Lease and Phased Lease Agreement predicated mainly on changing the use of the approved 650 multi-family rental units to condominiums. After nearly four and a half hours of tenant presentation, public comment by dozens of citizens and Commission dialogue, the Commission arrived at a consensus on the next steps: doing nothing for the remaining 41 years on the lease is not an option; no condominiums; and keep the lines of communication with the tenant open in order to ensure that the City is no longer stuck with the paltry \$1.5 M annual revenue from the tenant. Renegotiating the lease paves the way for a better deal for rental income, better Boat Show partnership and possibilities, fewer buildings on the site, more open space or even the City buying out the lease. I take the tenant's Counsel seriously when he says, "Everything is on the table."

The discussion also revealed the need for transparency and regular updates from the City Attorney and City Manager regarding major issues such as Bahia Mar and the Boat Show leases and agreements. I want to thank the many people who provided valuable and diverse input on this precious public land. The conversation was most constructive and I am pleased to serve as a liaison with the tenant in reimagining this site and ensuring that the public has abundant access and amenities while the City sees its fair share of revenue from any and all leases. Let's get to work!

New 3D Module Enables Users to View Development Review Committee Projects

The City of Fort Lauderdale, in conjunction with Gridics, LLC, has launched the 3D Projects module within the Gridics Municipal Zoning Platform. The updated application includes the City's Code of Ordinances and Unified Land Development Regulations. Citizens will now be able to access an up-to-date and fully digitized version of the code text, plus an interactive 3D zoning map and parcel-specific tools to look up zoning and property record data.

With its unique technology, Gridics gives municipalities the ability to establish a zoning property record data set for every parcel in one comprehensive zoning code management platform. The 3D Projects Module will help City staff and citizens solve common planning and zoning issues by:


- 1. Unifying 3D interactive zoning maps and code text in one easy-to-use interface.
- 2. Providing online citizen self-help tools to reduce front counter zoning inquiries.
- 3. Allowing municipal staff to quickly view citywide development potential and visualize 3D scenarios.

The Module also allows residents, real estate developers, and other interested parties to view 3D models of development projects that have been submitted to the Fort Lauderdale Development Review Committee. Projects are presented citywide within the 3D zoning map, giving the viewer an understanding of the review and approval status and how the city landscape will change with the addition of new developments.



COVID-19 Vaccinations in Broward County

Who Can Get Vaccinated?

The State is currently prioritizing vaccination for (1) seniors ages 65 and older; (2) long-term care facility residents and staff; (3) health care personnel with direct patient contact; (4) K-12 school employees 50 years of age and older; (5) sworn law enforcement officers 50 years and older; (6) firefighters 50 years of age and older; (7) individuals deemed to be extremely vulnerable to COVID-19 by a physician.

Where Can I Get A Vaccine?

State-Run Appointment System and Locations:

The Florida Division of Emergency Management launched a statewide preregistration system for COVID-19 vaccine appointments. Eligible residents can visit <u>myvaccine.fl.gov</u> to pre-register for vaccine appointments that become available in their area.

Those who have registered will be contacted by phone call, text, or email when appointments become available.
