# I. Call to Order and Determination of Quorum

# II. Approval of BRB Meeting Minutes

## • July 20, 2020 Regular Meeting

## III. Beach Project Updates – Thomas Green, PE, Senior Project Manager

Thomas Green, Senior Project Manager, provided updates as follows:

## Aquatic Center

The pour has been finished for the dive well; all walls, fountain, and floor are done, ribbon cutting is expected July of 2021 for the pool. They are working on design and purchasing items for the south building with a 12/10/20 target date, to include locker rooms, timing room, and the "brains" of the aquatic center. There will be two ribbon cuttings.

### Las Olas Corridor

99.9% of the construction has been completed; outstanding warranty and punch list items are being addressed.

### DC Alexander Park

Between 60-90% of design has been completed, permitting has begun, drawings should be done by October. A solicitation for the contractor will go out this year with an anticipated start date of 1st or 2nd quarter of 2021.

#### Almond Avenue sidewalk improvements

Design is completed, repairs will cost \$100,000 budgeted, funding is in place; 4th quarter of 2020 repairs should be complete.

#### A1A Streetscapes

Bid documents complete and sent to FDOT, construction should begin late 2020/early 2021.

#### Las Olas Park

Mr. Hughes inquired regarding placing locks on the power outlets to discourage use by the general public. Mr. Green stated locks are not being utilized at this time; however, consideration will be given to affixing secure locks to the outlets.

#### VII. Old/New Business

Mr. Clarence Woods, the new CRA Manager, was introduced to the Board members.

Mr. Woods noted this would be the last meeting of the BRB; however, there has been discussion regarding establishing another organization so that updates on beach projects can be given to members within the community.
