CITY COMMISSION CONFERENCE MEETING

Discussion on the Office of the City Clerk

At the request of the City Commission, staff gave an overview of the succession plan for the City Clerk's Office upon the departure of the City Clerk in January 2022. The commission and staff discussed the advantages and disadvantages between hiring a clerk from outside the City versus appointing an internal candidate. The City Commission agreed to promote from within, offering the current Deputy City Clerk the position, citing the importance of continuity of operations and institutional knowledge an internal appointee would provide. CRA Board Accepts Seven Residential Properties for Affordable Housing

The City Commission, acting as the Community Redevelopment Agency (CRA) Board of Commissioners, passed a resolution to accept the instruments of conveyance for seven residential properties owned by the City of Fort Lauderdale to be used for affordable housing. The resolution authorizes the Executive Director to execute all related actions associated with the seven properties including, contract with companies for appraisal, title, survey, demolition, site cleanup and related services, and authorize the issuance of Request for Proposals for the development of the properties. The properties that will be deeded for public use are in the following neighborhoods: Northwest Progresso Flagler Heights Community Redevelopment Area, Dorsey Riverbend, Durrs and Middle River Terrace. CITY COMMISSION REGULAR MEETING

City Commission Approves Lease Amendment with FDOT for the Henry E. Kinney Tunnel Project

The City Commission approved a lease amendment with the Florida Department of Transportation for right-of-way above the Henry E. Kinney Tunnel to restrict public access and begin construction. The construction on the Henry E. Kinney Tunnel Top Pedestrian Plaza begins in early 2022, and the anticipated completion date is early 2023. City Commission Accepts Florida Department of Transportation Grant

The City Commission approved the acceptance of a grant in the amount of \$30,000 from the Florida Department of Transportation (FDOT). The funding will help establish a motorcycle safety program to reduce the frequency of traffic safety concerns in identified hot spots. Education and enforcement activities will focus on improving awareness of risky behaviors that contribute to motorcycle traffic violations and accidents. City Commission Adopts Resolution Authorizing Florida Power & Light

The City Commission adopted a resolution authorizing the City Manager to execute three Florida Power & Light (FPL) easements over city-owned property for utilities at the DRV PNK Stadium. The resolution will allow FPL the right to ingress and egress, and maintenance of overhead and underground electric utility facilities to be installed within city-owned property. The resolution will give the City Manager authority to grant FPL access to maintain overhead and underground utility facilities and install electrical infrastructure. City Commission Amends Grant Agreement with War Memorial Benefit Corporation

The City Commission approved to amend the grant with War Memorial Benefit Corporation (WMBC) by extending the completion deadline to July 1, 2022. The extension was requested due to the impact of COVID-19 significantly delaying the construction timeline. The City entered into the lease agreement with WMBC in 2019 to enhance the War Memorial Auditorium. The grant agreement is for capital improvements in the amount of \$800,000. Event Agreement for Friendsgiving Weekend Get Together

The City Commission approved an event agreement with American Social, Inc. for a Friendsgiving Weekend Get Together scheduled for Friday, November 26 through Sunday, November 28 at American Social on East Las Olas Boulevard. The event agreement allows for

City Commission Considers Site Plan Review for 808 SE 4th Residence

After listening to public comment, the City Commission approved in a 3-2 vote, a motion approving a de-novo hearing to further review the application for a proposed site plan for the project known as "808 SE 4th Residence." The Planning and Zoning Board approved the project subject to the 30-day City Commission request for review and improvements proffered by the applicant. The site is in a RAC zoning area and the applicant, SE Fourth, LLC., proposed to redevelop the existing residential building consisting of 34 units into a new 77-unit residential building. City Commission Approves an Ordinance Amending Landscape Irrigation Conservation Measures

The City Commission approved an ordinance on first reading to amend the City's Code of Ordinances relating to year-round landscape irrigation conservation measures. The amended ordinance will reduce irrigation from three to two days per week, potentially saving up to one billion gallons of water a year. The mandatory ordinance is consistent with the South Florida Water Management District's Florida Administrative Code, and implements procedures to protect water resources and promote water conservation through the efficient use of landscape irrigation.
