The meeting was called to order at 9:01 A.M.

The property was not in compliance, fines had accrued to \$13,350 and the City was requesting imposition of the fines, which would continue to accrue until the property was in compliance.

Jose Saragusti, Building Inspector, reported the demolition permit application had been submitted on 2/15/22. The property was not in compliance, and he recommended a 28-day extension.

John Brown said it had taken two years to get to this point with the demolition. The application still needed a few signoffs.
