Please provide a response to the following:

- 1. Specify uses and occupancy classification per Chapter 3 of the 2020 FBC.
- 2. Show provisions for either open or closed interior parking per section 406.5 or 406.6 of the 2020 FBC.
- 3. Specify height and area compliance per Chapter 5 of the 2020 FBC.
- 4. Specify fire-resistance rating requirements based on building separation per Table 601 and 602 of the 2020 FBC.
- 5. Provide occupancy loads with compliant life safety egress design per Chapter 10 of the FBC
- 6. Designate Fair Housing Provisions per the 2020 FBC Accessibility volume.
- 7. Dimension accessibility requirements to site per the 2020 FBC Accessibility Code.
- 8. Show that exits stairways discharge directly to the exterior of the building leading to the public way FBC 1028.
- 9. Provide accessible route connecting handicap parking spaces to accessible building entrances per FBC Accessibility volume.
- 10. Show that the separation between the exit access stairways meet the requirements of section 1007 of the 2020 FBC.
- 11. Exterior exit door must be readily visible and identifiable from interior exit stairways terminating at a lobby per section 1028.1.1.1 of the FBC.
- 12. Specify the Florida Building Code 7th edition on plan for the proposed development [FBC 2020-101.2]

GENERAL COMMENTS

The following comments are for informational purposes. Please consider the following prior to submittal for Final DRC:

- The Florida Building Code shall apply to the construction, alteration, movement, enlargement, replacement, repair, equipment, use and occupancy, location, maintenance, removal and demolition of every building or structure or any appurtenances connected or attached to such buildings or structures.
- 2. All projects must consider safeguards during the construction process. FBC Chapter 33 delineates various safeguards that may apply during the construction phase. All structures associated with the protection of pedestrians will require a separate permit. A licensed professional must sign and seal the plans and specifications.
- 3. The City of Fort Lauderdale is a participating municipality in the National Flood Insurance Program (NFIP). The requirements specific to the City of Fort Lauderdale can be found in

Chapter 14 - FLOODPLAIN MANAGEMENT of the Code of Ordinances and accessed at;

Please consider the following prior to submittal for Building Permit:

- 1. On December 31st, 2020 the 7th Edition of the Florida Building Code was adopted. All work described in Section 101.2, of the Broward County Administrative portion of the Florida Building Code, will govern the administration and enforcement of the proposed work. <u>DEDICATION OF RIGHTS-OF-WAY:</u> Per ULDR Section 47-25.2.M.5, property shall be conveyed to the public by plat, deed or grant of easement as needed in accordance with the Broward County Trafficways Plan, the city's comprehensive plan, subdivision regulations and accepted applicable traffic engineering standards:

- a. Prior to Final Survey approval a 5' permanent Right-of-Way Easement will be required along the east side of SE 2nd Avenue, to complete half of 50' Right-of-Way section per ULDR Section 47-24.5.D.I.
- b. Prior to Final Survey approval a 5' permanent Right-of-Way Easement will be required along the north side of SE 8th Street, to complete half of 50' Right-of-Way section per ULDR Section 47-24.5.D.I.
- c. Prior to Final Survey approval a 5' permanent Right-of-Way Easement will be required along the south side of SE 7th Street, to complete half of 50' Right-of-Way section per ULDR Section 47-24.5.D.I.
- d. Provide permanent Sidewalk Easement as appropriate along south side of SE 2nd Ave to accommodate portion of pedestrian clear path (coordinate required width with TAM) that may be located beyond public Right-of-Way and/or Right-of-Way Easement dedication (per City's Downtown or Northwest RAC Master Plan guidelines as appropriate); show / label delineation in the plans.
- e. Provide permanent Sidewalk Easement as appropriate along north side of SE 8th Street to accommodate portion of pedestrian clear path (coordinate required width with TAM) that may be located beyond public Right-of-Way and/or Right-of-Way Easement dedication (per City's Downtown or Northwest RAC Master Plan guidelines as appropriate); show / label delineation in the plans.
- f. Provide permanent Sidewalk Easement as appropriate along south side of SE 7th Street to accommodate portion of pedestrian clear path (coordinate required width with TAM) that may be located beyond public Right-of-Way and/or Right-of-Way Easement dedication (per City's Downtown or Northwest RAC Master Plan guidelines as appropriate); show / label delineation in the plans.
- g. Provide permanent Sidewalk Easement as appropriate along west side of SE 3rd Avenue to accommodate portion of pedestrian clear path (coordinate required width with BCHCED and TAM) that may be located beyond public Right-of-Way; show / label delineation in the plans.
- h. Provide 10' x 15' (min.) permanent Utility Easement for any 4 Inch or larger water meter and/or the first private sanitary sewer manhole located within the proposed development (for City Maintenance access); show / label delineation in the plans as appropriate.

Prior to Planning and Final DRC sign-off, please provide updated plans and written response to the following review comments:

- 1. Meet the City's Adequacy requirements to services provided to the public (fire service, water, wastewater, stormwater, transportation, etc.), per ULDR Section 47-25.2 of the City's Code of Ordinances. Assess potential demands and impacts on City services and prepare a design for each that utilizes existing water, wastewater, stormwater, and transportation infrastructure to adequately serve this project. If the adequate infrastructure is not available, prepare a design that extends/expands the connection to the nearest City system to adequately serve this development.
 - a. Prepare service demand calculations for water & wastewater services and obtain a letter of service availability from the City's Public Works Engineering Department. Submit water and wastewater capacity availability request form and documents/ plans at https://www.fortlauderdale.gov/government/departments-a-h/development-service-service-demand-calculations-for-water-sewer-request-form

2. Provide a current signed and sealed boundary and topographic survey showing all above ground improvements, utilities, rights of way dimensions and all easements. This survey shall be based on a Standard Title Commitment issued by a title insurer licensed to do business in Florida or an Opinion of Title issued by an attorney admitted to the Florida Bar. The title commitment or Opinion of Title must have an effective date no more than thirty days prior to the date of submittal of the survey and must be certified to the City of Fort Lauderdale. If any encumbrances are found in the property, provide a copy of the recorded documents accordingly (i.e. easements, dedications, agreements, vacations, etc.).

- 3. Please provide a plan depicting all Right-of-Way Easements, dedications, Sidewalk Easements and Maintenance areas.
- 4. Provide disposition of existing utilities on-site and within the adjacent right of way that maybe impacted by the proposed development. Label information on plans (i.e. utility to remain/ be relocated/ removed). Provide correspondence from utility owner (as applicable) and depict any additional requirements they may have on plan (i.e. easements). Utilities include but are not limited to above and underground water, sewer, drainage, electrical, communications, light/power poles, down guys, fire hydrants, manholes, etc.
- 5. Proposed 10FT Right-of-Way easement along SE 3rd Avenue on sheet C-2 is not accurately labeled. SE 3rd Avenue currently meets the Broward County Trafficways Plan. Please provide a sidewalk easement to accommodate portion of pedestrian clear path (coordinate required width with TAM) that may be located beyond public Right-of-Way and/or Right-of-Way Easement dedication (per City's Downtown or Northwest RAC Master Plan guidelines as appropriate); show / label delineation in the plans.
- 6. Proposed required on-site improvements (i.e. building, foundation, back flow preventer, fdc, clean out, doors, etc.) shall not be constructed within existing or proposed right of way/ dedications/ easements.
- 7. Proposed required on-site improvements (building, foundation) shall not be constructed within 25FT sight triangles at the intersection of SE 2nd Ave and SE 7th street as well as the intersection of SE 2nd Ave and SE 8th Street. Sight triangle shall be measured from the point of intersection of the dedicated easement line.
- 8. Clearly indicate on plans the limits of construction and how the proposed improvements will transition into the existing (on-site and off-site) as applicable.
- 9. Depict/ label existing/ proposed stop sign/ bar on right of way adjacent to the site and on driveway connections to right of way as applicable.
- 10. More accurately show and label existing utility pedestal and concrete pad, located near northeast corner of proposed development (within Right-of-Way).
- 11. Per ULDR Section 47-2.2.Q, show and label sight triangles as appropriate for safe and adequate access of drivers and pedestrians, on the Site Plan, Landscape Plans, and Civil Plans. Per ULDR Section 47-19.1.E, no accessory use or structure shall be permitted within a sight triangle except as provided in <u>ULDR Section 47-35</u>. Ensure sight triangles are also depicted on adjacent driveways that would be impacted by proposed improvements on this project. Sight triangles located at the intersection of a local street or driveway with a right-of-way under County, State or Federal jurisdictions, are subject to the sight visibility requirements of those jurisdictions.

- 12. Ensure sufficient height clearance is provided within garage for truck access.
- 13. Provide and label typical roadway cross-sections for the proposed development side of SE 2nd Ave, SE 8th Street, SE 7th Street, and SE 3rd Ave: at driveway access points, at on-street parallel parking lanes, and at landscape swale areas (i.e. between travel lane and sidewalk) as appropriate.
- 14. Depict existing sidewalk adjacent to the development along SE 2nd Ave, SE 8th Street, SE 7th Street, and SE 3rd Ave and how proposed sidewalk/ pedestrian path will transition into existing sidewalk.
- 15. Per ULDR Section 47-20.17, show and label on Site Plan the Vehicle Reservoir Spaces (VRS) required for the proposed development a minimum 10' x 20' area for each vehicle to be accommodated for the temporary stopping of a vehicle awaiting service, which shall be located in an area within a parking facility which is not used for any other vehicular use such as access, parking, site circulation or loading. Each VRS shall be in a location that does not conflict or interfere with other traffic entering, using or leaving the site; design configuration shall be such that there shall be no backing into the street permitted.

Clarify whether the proposed parking is 100% valet or not. Depict information on site plan data table/plans accordingly.

- 16. For all levels in the parking garage:
 - b. Provide all sheets for parking levels 3 through 7.
 - c. The minimum clear width and depth parking stall dimensions shall be 8'-8" and 18'-0", respectively, and shall not be encroached upon by building columns.
- 17. Show and label dimensions for dead-end parking spaces as appropriate for vehicular turnaround. Per ULDR Section 47-20.5.C.4, dead-end parking areas shall be prohibited, except where the number of parking spaces in the dead end area is less than 21 and a turnaround area is provided which will accommodate a 2-point turn around by a standard passenger car (AASHTO "P" Design Vehicle) or where the number of parking spaces in the dead end is 10 or less.
- 18. Discuss if private parking area will be separated from general parking area with gates.
- 19. Per ULDR Sec. 47-20.13.D On-site stormwater retention shall be provided in accordance with the requirements of the regulatory authority with jurisdiction over stormwater management System. Therefore, please provide drainage calculation showing proposed design will meet applicable South Florida Water Management District design criteria.
- 20. Drainage mitigation is required for any impacts within adjacent City of Fort Lauderdale Right-of-Way, such as increased runoff, additional impervious areas, and reduction of existing storage or treatment (i.e. swale areas). Engineer of Record (EOR) shall evaluate the adjacent City roadway system capacity and demonstrate that the proposed improvements will not negatively impact the City's existing drainage system, and provide recommendations in compliance with the City's Comprehensive Plan (i.e. meets or exceeds the 10-year/1-day storm event drainage criteria).
- 21. Please provide reasonable assurances that the drainage system will be able to be effectively operated and maintained. Response shall include the following at a minimum:
 - d. Detailed information regarding the structural design of the building and provide a certified geotechnical and structural engineering analysis to demonstrate that the proposed drainage system will not undermine the structural components of the building.

- e. Provide plans demonstrating how will the drainage structures will be accessible by equipment required to maintain the system and or replaced the system in the event of failure.
- 22. Show and label all existing and proposed utilities (utility type, material and size) on civil and landscaping plans for potential conflict. A min. 5 feet and 10 feet horizontal clearance horizontal separation is required between city utilities infrastructure and proposed small and large trees, respectively (including proposed water and sewer services to the development). Any new trees (located within or adjacent to City Right-of-Way) should be placed with sufficient horizontal and vertical distances (per City, County, and State guidelines) to / from City's public infrastructure, including stormwater assets, to allow for continued Public Works maintenance without obstruction. If this cannot be accommodated due to field conditions, then the developer shall relocate the existing City's public infrastructure to resolve the conflict(s) and to comply with City's, County's & State's engineering standards/permits/policies. Ensure separation is provided and include a note regarding horizontal clearance requirement on the landscape plans.
- 23. The proposed pedestrian lighting along City Right-of-Way, requires perpetual maintenance by the Applicant via a Maintenance Agreement executed with the City. Please contact the Case Planner for details to match the area.
- 24. Provide Maintenance Agreement Area Exhibit, which provides a visual representation of the area within the adjacent public Right-of-Way (adjacent to the proposed development) to be maintained in perpetuity by the developer. Label whether the adjacent Right-of-Way is BCHCED, or City jurisdiction, as well as label all proposed improvements, including asphalt and other specialty paving, specialty sidewalks, landscaping, irrigation, lighting, curb and gutter etc. that will be maintained by the Applicant throughout the life of the improvements. Perpetual maintenance of newly constructed exfiltration trenches, inlets, etc. within adjacent City Right-of-Way will typically revert back to the City, upon successful inspection/acceptance by Public Works after 1-year warranty period.

Be advised a corner chord Right-of-Way dedication or permanent Right-of-Way Easement on northeast corner of SE 3rd Avenue and SE 7th Street and the southeast corner of SE 3rd Avenue and SE 8th Street intersection (coordinate with BCHCED) may be required. Clarify with BCHCED if Right-of-Way dedication or Right-of-Way Easement will be required.

Please provide a response to the following.

- 1. For specimen size trees, provide ISA Certified Arborist report for specimen trees, as per ULDR 47-21.15. This report is to be on ISA Certified Arborist business letterhead with contact information and ISA Certification number clearly stated. This report would include tree survey with numbered trees, a corresponding table which includes tree number, botanical name and common name, trunk diameter at breast height, clear trunk for palms, condition percentage, etc., and a written assessment of existing tree characteristics. This information is required to calculate equivalent value mitigation.
- 2. Tree preservation requirements apply and should be followed. Please investigate candidates for relocation in place of removal and mitigate. Please have ISA Arborist evaluate site trees for relocation.
- 3. Light fixtures with an overall height of more than ten feet shall be located a minimum of 15 feet away from shade trees, as per ULDR Section 47-21.12.
- 4. Utilities and site amenities such as walkways, flagpoles, transformers, fire hydrants, sewer and water supply lines, trash enclosures, and similar items located on the site shall not be placed adjacent to, in, or under required tree planting areas, as per ULDR Section 47-21.12. Confirm with civil, site and life safety plans that utilities and site amenities are not causing conflicts with proposed landscaping. Where conflicts exist, shift the utility and/or site amenities. Proposed off-site drainage system is preventing proper placement of shade trees within the landscape area of the bulb-outs.
- 5. Street trees to be placed on 30 feet centers. Trees located in the landscape strip between the parking stall and sidewalk may be closer to the trees within the landscape area of the bulb-out.
- 6. Please provide FDOT line of site along SE 3rd AVE.
- 7. There is an existing bus stop along SE 3rd AVE with out proposal on the plans. Please coordinate with the County to have the bus stop toward the south end of the site.
- 8. As to Design Guidelines overhead utilities to be relocated. Please relocate the overhead utilities underground may you please include those that cross over SE 7th Street and SE 8th Street.
- 9. Additional comments may be forthcoming after next review of new plans and written comment responses.

Please consider the following prior to submittal for Building Permit:

1. A separate sub-permit application for Tree Removal, Relocation, and General Landscaping for site is required at time of master permit submittal. These are Landscape and Tree permit application documents different than the Broward County standard applications. Please not this at time of submittal.



- 2. Proposed landscaping work in the City's right of way requires engineering approval. This approval requires documents to be submitted for Engineering review. Note that Landscape will not approve permit review without these Engineering documents being submitted.
- 3. Approval from jurisdiction for landscape installation in Right of Way preferred prior to final DRC sign off but may be provided at time of permit submittal. If jurisdiction approval is obtained after DRC final sign off and the plans require any change, Administrative Review will be required prior to permit review.

Please provide a response to the following:

- 1. Residential and retail units' entry and exterior doors should be solid, impact-resistant, or metal.
- 2. Residential units' entry doors should be equipped with a quality secondary deadbolt locking system and have a 180-degree peephole or viewport for security.
- 3. Retail unit doors exterior doors should be equipped with burglary resistant lock systems like door pins or lock security plates.
- 4. The site should be equipped with a comprehensive CCTV system that can retrieve an identifiable image of an individual on-site. The system should cover all entry-exit points, parking garage, common areas, mailroom, storage areas, and any sensitive area of the site.
- 5. Ground-level stair doors should be egress only or access controlled. Stair doors into floors should be access controlled.
- 6. All elevator lobbies and/or elevators should be access controlled.
- 7. The parking garage should be equipped with vehicular access control systems to prevent unauthorized intrusion or access to residents' vehicles.
- 8. Easily identifiable emergency communication devices should be available at the pool areas, common areas and the parking garage.
- 9. There should be child-proof safety features to prevent unsupervised children access to the pool.
- 10. Lighting and landscaping should follow C.P.T.E.D. guidelines.

- 1. Garbage, Recycling and Bulk Trash shall be provided.
- 2. Recycling reduces the amount of trash your business creates, and it is the best way to reduce monthly waste disposal costs and improve your company's bottom line.
- 3. Solid Waste Services shall be provided by a Private Contractor licensed by the City.
- 4. Service Days shall be: No restriction for Commercial collection. Service may not occur earlier than 7:00 am or later than 7:00 pm within 250 feet of residential.
- 5. Solid Waste charges shall be included in monthly maintenance fee as prescribed in owner's association documents (multi-family).
- 6. Solid Waste charges shall be collected in monthly lease with Sanitation account for property under one name (Commercial).
- 7. Solid waste collection shall be from a private loading area.
- 8. Solid Waste Collection shall be on private property container shall not be placed, stored, or block the public street to perform service (large multifamily and commercial parcels).
- 9. Provide on the site plan a garbage truck turning radii for City review. Indicate how truck will circulate within property.
- 10. Show containers on site plan. Trash room must accommodate trash and recycle containers.
- 11. Trash Room services will be handled by private collector, or Trash Room services will be done by on site personnel, or Trash Room services will be done by custodial staff.
- 12. Containers: must comply with 47-19.4
- 13. Submit a Solid Waste Management Plan on your letterhead containing name of project, address, DRC case number, number of units if applicable, and indicate whether it is Pre or Final DRC.
 - This letter is to be approved and signed off by the Sustainability Division and should be attached to your drawings. Please email an electronic copy to dwilson@fortlauderdale.gov. Letter should include an analysis of the expected amounts of solid waste and recyclables that will be generated (if different from current capacity), and container requirements to meet proposed capacity.

- 1. A traffic impact study has been submitted. Please coordinate with the Transportation and Mobility Department on the review of this document. Staff and consultant's review concerns shall be adequately resolved prior to gaining authorization for either the Planning & Zoning Board or City Commission hearings. Take into consideration that the review of this study will take about 4-6 weeks once all documents are received.
- 2. Provide clarification on garage operation and accessibility (gate, ticket gate, etc.) for this development. Please note that if a gate is proposed, a queueing analysis based on the gate operations will be required as part of the Traffic Impact assessment.
- 3. Show inbound and outbound stacking requirements from the property line to the first conflict point according to Section 47-20.5 General design of parking facilities for the driveway. Please note that if there is proposed gate at the ingress and egress points for this development, the gate will be considered the first conflict point.
- 4. Provide pedestrian crossing signs for the north-south crosswalk located at the intersection of SE 7th Street and SE 2nd Avenue.
- 5. Include a table showing the proposed land uses, the floor area in square feet for each land use, the parking ratio, the number of parking spaces required by type, and the number of parking spaces proposed by type (standard, compact, handicapped, bicycle, loading, etc.). ULDR Sec. 47-20.2. -Parking and loading zone requirements.
- 6. All parking must be provided in accordance with design and construction standards of the ULDR Section 47-20.11. Show dimensions for: stall width, depth of stall 90 degrees to aisle, aisle width, width of stall parallel to aisle, module width, angle of parking stalls for off-street and on-street parking stalls.
- 7. Per ULDR Section 47-2.2.Q, show and label sight triangles as appropriate for safe and adequate access of drivers and pedestrians, on the Site Plan, Landscape Plans, and Civil Plans: intersections of driveways with streets and alleys (10' measured from intersection point of pavement edges), alleys with alleys (15' measured from intersection point of extended property lines), alleys with streets (15' measured from intersection point of extended property lines), and streets with streets (25' measured from intersection point of extended property lines). The request for reduction of sight triangle dimensions is subject to review by the City Engineer on a case-by-case basis. Per ULDR Section 47-19.1.E, no accessory use or structure shall be permitted within a sight triangle except as provided in ULDR Section 47-35. The City of Fort Lauderdale reserves the right to meter on-street parking stalls in the public right of way at any time.
- 8. The city reserves the right to meter on street parking stalls on the public right of way at any time.
- 9. Please add the following note on the site plan for the on-street parking, "None of the on-street spaces are reserved for the development and may be used by any member of the public. On-street spaces will not count towards the parking requirements for the project; The spaces may be removed at any time for any reason and the City of Fort Lauderdale will not relocate displaced on-street parking."
- 10. Remove on-street parking from the parking data table as it cannot be counted toward the parking requirements for this project.

- 11. All internal circulation and queuing areas must be designed to accommodate the turning radii of the vehicles that will be using the site. Provide auto turn vehicular paths to depict how the ground floor site circulation will work.
- 12. Provide stop bar locations for garage circulation review.
- 13. Per ADA guidelines, an accessible route must always be provided from the ADA parking to the accessible entrance. Please indicate on plans that ramp will be provided to access the pavement on the back of parking area which leads to the elevator lobbies.
- 14. Coordinate with Broward County for proper design of their existing bus stop location located on SE 3rd Avenue.
- 15. All loading and unloading must be contained on site including postal delivery services and rideshare pick up and drop off.
- 16. Ensure all access points, sidewalks, walkways, and curb cuts are unobstructed and ADA accessible with appropriate slopes and detectable warning devices and indicate on the site plan. This includes all access to/from the site entrance. Add the dimension, clearances, and slopes of the walkways.
- 17. Sidewalks must be straight and direct pedestrians to clear pathways, remove any structures, poles and landscaping from the sidewalks that are disrupting this clear path.
- 18. Ensure sidewalk is a minimum of 7 feet wide on **SE 3rd Avenue**, **SE 2nd Avenue** and **SE 7th Avenue**. This minimum is in reference to clear, unobstructed pathways –Light poles, trees and landscaping is not to be included in this zone. - 8. In regard to physical, communication, and radar obstructions, the Federal Aviation Administration (FAA) requires a review for interference by the proposed constructions. Provide a letter form the FAA indicating that such review has been performed. FAA approval must be obtained prior to Final DRC sign-off unless otherwise deemed unnecessary by the City Airport Director or designee.
- 9. Provide a preliminary construction staging plan which includes anticipated hours of operation on site, debris mitigation plan, and map indicating where crane operations and employee and/or equipment parking and storage will be placed. A revocable license application and a traffic circulation plan may be required if the sidewalk or right-of-way requires to be closed at any time, which should be filed under a separate application and coordinated through the City's Maintenance of Traffic (MOT) process with the Transportation and Mobility Department.

- 15. The project does not meet certain Downtown Master Plan design intents as outlined in ULDR, Section 47-13.20 and Section 47-13.21, respectively. Staff has commented below under the applicable category and has provided images to assist the applicant.

<u>Principles of Building Design Standards</u>

- a. B-2: Framing the street: encourage open space site requirements for use as pedestrian public space instead of unusable, leftover 'green perimeter'.
- b. B-3: Frame the street: minimum and maximum building street wall heights. The maximum streetwall height is 7 floors, whereas the
- c. B-4: Framing the street: Maintain maximum building streetwall length of 300 feet. Consider breaking up the building.
- d. B-8: building exceeds the maximum streetwall length of 150-feet and project must provide Character Area (Near Downtown)
 - a. 2A *ULDR*: Frame the street with appropriate streetwall height: Shoulder: 7 floors max with minimum 15-foot stepback on portion over 7 floors.
 - b. 2B *ULDR*: Maximum building height of 30 floors

As proposed, the building footprint and overall site layout along SE 3rd Avenue leaves minimum space for adjustments, limited space for pedestrian respites and lacks overall connectivity of uses to the public realm, both internally and externally. The site layout should be re-evaluated to: (1) provide stronger building presence that aligns with ground level uses and activities, (2) create more significant building entrances that align with proposed uses, (3) increase open space and usable pedestrian urban space areas, and (4) consider reducing development program to balance proposed uses with dimensional standards, open space and parking needs, meeting all Downtown Master Plan guidelines. - 17. Provide an open space diagram that depicts the various open space requirements per ULDR Section 47-13.20.E. Vehicular areas cannot be included in the calculations and open space areas on the amenity levels must be accessible to qualify. Staff recommends color coding the open space information to clearly identify what areas are being counted as open space.
- 18. Provide pedestrian perspective along SE 3rd Avenue.
- 19. Provide a contextual plan depicting the adjacent buildings to ensure consistency if buildings along on streetscapes.
- 20. Additional detail drawings are needed and at a minimum should include the following: street cross sections, close-up detail elevations for the lower levels, specifically in areas where there is a grade change with stairs and ramps, building corners, screening materials, railing, etc. Provide images of the products in real life applications and specifications.
- 21. Pursuant to ULDR Section 47-20.14, Photometrics values should be shown to the property lines. Depict this information accordingly.
- 22. Provide documentation from Broward County regarding the dedication for right-of-way along SE 3rd. Avenue as well as any proposed landscape within the right-of-way. Email communication is sufficient. Discuss public access area easements and hours of operation on the property for the sidewalk, public plaza areas, or open space areas, as identified on Site Plan Sheet AR-001 with staff. Applicant shall provide the public 24-hour access to any public access areas that are utilized as part of the public sidewalk, along a public right-of-way for entire project frontage. Any required easements shall be vetted with Planning, Engineering and City Attorney's Office and provided to the City and/or appropriate government entities prior to obtaining a certificate of occupancy or certificate of completion, as applicable, from the City.
- 23. Although site plan includes private garages (preferable for overnight or long-term bicycle storage), it is strongly recommended that external bicycle parking also be provided. It is a convenient amenity for residents, especially for children and guests. If shared amenities are provided, include additional bike parking at those locations. Ensure parking is located in visible, well-lit areas as close as possible to

- 24. Pursuant to ULDR Section 47-19.2.Z, all rooftop mechanical equipment areas, stair and elevator towers should be designed as in integral part of the building volume and shall be required to be screened with material that matches the material uses for the principal structure and shall be at least as high as six (6) inches above the top most surface of the roof mounted structure. Address the following:
 - a. Provide detail drawings(s) with spot elevations of the parapet wall and roof level as well as top of mechanical equipment to verify adequate screening of roof mounted equipment.
 - b. Identify the location of equipment on building elevations by outlining the equipment with dash lines.
 - c. Ensure the screening material is made of durable material.
 - d. Provide screening product material including images or pictures of actual application of such.
- 25. Consider employing green practices throughout the project including, but not limited charging stations, tank-less water heaters, rain collections system, pervious parking, bio-swales, Florida Friendly™ plant materials, and solar panels.
- 26.
