Pursuant to the United States Department of Housing and Urban Development (HUD) statutory regulations, 24 CFR Part 91, the City of Fort Lauderdale (City) has prepared its Consolidated Annual Performance and Evaluation Report (CAPER) for program year 2022 ending September 2023. The CAPER describes the City's use of grant funds and identifies housing and community development priorities that align and focus funding from the grant programs, including Housing Opportunities for Persons with AIDS (HOPWA), Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and other leveraged resources such as the City's local housing trust fund and State Housing Initiatives Partnership (SHIP). The Report includes a summary of expenditures and outcomes for the grant fiscal year 2022-2023. For the program year 2022-2023 CAPER, Grantees are required to submit a performance report within 90 days after the close of a jurisdiction's program year. The City is submitting its CAPER report in compliance with federal regulations on December 30, 2023.

The public is invited to review and comment on the City's 2022-2023 CAPER. HUD regulations allow for a 15-day minimum comment period. The comment period is from Wednesday, December 6, 2023, through Wednesday, December 20, 2023.
