

GENERAL PROJECT NARRATIVE



I. <u>INTRODUCTION</u>

Situated on the southeast portion of the site, Marina Village is set to offer a wide range of culinary and entertainment options, catering to both residents and tourists. This vibrant hub will feature eight distinct food service kiosks alongside the ticket booth and terminal for Fort Lauderdale's esteemed Jungle Queen.


This application is a sign package for the Marina Village. Marina Village will be a unique destination in the area that lends itself to unique signage. These signs will not only serve as visual beacons, but also play a crucial role in site identification and communication. The signage will also give the area a playful feel, assisting in transforming the area into a true standalone village. A total of thirty-one (31) signs are slated for Marina Village, categorized into the following styles: two (2) monument, thirteen (13) Channel, eight (8) Cabinet, and eight (8) Blade, each contributing to the overall ambiance and functionality of Marina Village. The table in Section V of this narrative provides the code-comparison table.

II. <u>SOUTH MONUMENT SIGN</u>



The South Monument Sign, or "Sign 1", is strategically positioned at the south entrance of Marina Village. Measuring 120 inches in height, 85 inches in width, and 29 inches in depth, with a proposed square footage of 70.83', Sign 1 serves as a prominent visual marker, clearly indicating an entry point into Marina Village. Crafted from aluminum, Sign 1's face features ½ inch acrylic push-thru letters and translucent digital printing, presenting "MARINA VILLAGE" across the top and "BAHIA MAR" along the bottom. Its design, resembling a ship's wheel, pays homage to the maritime essence of the area. Mounted on round wooden posts adorned with sea strand rope, the aluminum sign exudes a marina-inspired aesthetic. Additionally, a decorative aluminum panel, situated across the posts, displays Bahia Mar's navigational coordinates and various nautical flags, further enhancing the desired maritime theme.

III. NORTH MONUMENT SIGN




The North Monument Sign, or "Sign 2", is situated at the north entrance of Marina Village, serving as a focal point for welcoming residents and visitors from Bahia Mar. Standing at 233 inches in height, 239 inches in width, and 29 inches in depth, with a proposed square footage of

386.71', Sign 2 embodies the grandeur of Marina Village's entryway. This premier sign boasts reverse channel letters with ½ inch acrylic push-thru faux neon details, elegantly mounted on horizontal tubes finished in dark wood. The RGB LED illuminated lettering spells out "Welcome to" at the top, "MARINA" below, and "VILLAGE" across the bottom. Positioned between round wooden posts adorned with sea strand rope, Sign 2 epitomizes the coastal charm of its surroundings. Complementing the main components of the sign, illuminated cabinet signs are mounted on the left and right posts, featuring a logo consistent with that of Sign 1, further enhancing the visual appeal and coherence of Marina Village's entrances.

IV. KIOSK SIGNS

Marina Village's primary purpose is to accommodate its distinctive standalone structures known as "kiosks". The Project features eight (8) kiosks in five (5) separate buildings, in addition to a standalone bar and the Jungle Queen ticket booth.


As each kiosk offers its own unique services, signage plays a crucial role in distinguishing one from the other while still maintaining a consistent and cohesive theme. Positioned at the southernmost point is the Jungle Queen Ticket Booth, followed by the Mainland Bar and eight food kiosks as Marina Village extends northward. The signage for the Jungle Queen Ticket Booth and Mainland Bar will feature channel letters across the top of the building. Each food kiosk will also display channel letters to identify its business name or featured menu item. Additionally, situated within each food kiosk, flat signage is positioned on the eastward-facing wall, as well as a protruding "blade" sign to help pedestrians identify the kiosks as they walk through the Village.



A. Jungle Queen Ticket Booth

The Jungle Queen ticket booth will include two signs, designated as "Sign 3" and "Sign 4". Positioned along the eastern and northern façades of the kiosk, these signs feature navy blue aluminum lettering, white day/night vinyl push-thru letters, and RGB LEDs, which emit a red or

amber hue when illuminated. Both Sign 3 and Sign 4 maintain a uniform height of 16 inches, width of 152 inches, and depth of 3.5 inches, resulting in a proposed square footage of 16.88'.



Like the Jungle Queen ticket booth kiosk, the Mainland Bar also features navy blue aluminum lettering, white day/night vinyl push-thru lettering, and RGB LEDs. Serving as the primary signage for Mainland Bar, Sign 5 is slightly larger than Signs 6 and 7 yet shares the same design features. Sign 5 spans 24 inches in height, 240 inches in width, and 3.5 inches in depth, resulting in a proposed square footage of 40'. Meanwhile, Signs 6 and 7 stand at 18 inches in height, 180 inches in width, and 3.5 inches in depth, totaling a square footage of 22.50'.


C. Kiosks 1 Thru 8

Each kiosk within Marina Village will host its own unique restaurant or food service business. The list of kiosks and their corresponding names or featured items is as follows:

- Kiosk 1: Taco Vibez
- Kiosk 2: Quore Gelato
- Kiosk 3: Blue Steel Pizza
- Kiosk 4: Burgers & Shakes
- Kiosk 5: Lobster Rolls
- Kiosk 6: Fresh Garden Bowls
- Kiosk 7: Yip
- Kiosk 8: Sushi Song


The kiosks will feature three types of signage: (i) channel letter signage mounted on top of the eyebrow of the building, (ii) cabinet signage attached to the eastern facing wall, and (iii) blade signage extending outward from the eastern facing wall beneath the overhanging eyebrow.

i. Channel Signage




Maintaining consistency within Marina Village, each kiosk will feature navy blue aluminum lettering with white day/night vinyl push-thru lettering and RGB LEDs for red or amber illumination. The channel signage for each kiosk will have a standard height of 16 inches and a depth of 3.5 inches. Depending on the length of the kiosk's name, the widths and square footage of these signs will vary accordingly.

ii. Cabinet Signage



Cabinet signage for each kiosk consists of aluminum with a painted finish. A ¹/₄ inch acrylic plaque, affixed to the navy-blue aluminum portion, features a full-color digital print logo as per the tenant of the kiosk. The cabinet signs maintain a uniform size, measuring 24 inches in height, 24 inches in width, and 4 inches in depth, resulting in a proposed square footage of 4'.



iii. Blade Signage


Blade signage follows a similar composition, featuring aluminum with painted finish and an acrylic plaque displaying the corresponding establishment's logo. These signs will be illuminated by an LED light fixture suspended from the wall's eyebrow. The blade signage dimensions are uniform, with heights of 12 inches, widths of 24 inches, and a depth of 4 inches, resulting in a total proposed square footage of 2'.


Marina Village Sign 3, 4 Site Plan - Blow up Jungle Queen








