Section A

- 1. Summary of the proposed ordinance, to include the public purpose to be served by the proposed ordinance, such as serving the public health, safety, morals, and welfare of the City.**

The proposed amendment will provide the City of Fort Lauderdale's City manager with the authority to impose additional parking enforcement measures for high impact events occurring on beach property related to parking non-compliance. This amendment will assist with the protection of beach property from damage, property degradation, and unauthorized use.

- 2. Estimate of direct economic impact of the proposed ordinance on private, for-profit businesses in the City.**

- a. Estimate of direct compliance costs that businesses may reasonably incur if the ordinance is enacted.**

There are no compliance costs associated with this amendment.

The proposed amendments will include a parking violation fee of \$125.00.
