- 4. Case Number 23-05-03 3081 NW 19<sup>th</sup> Street
  - Status Hearing

Detective Carlton Smith stated that in the previous 30 days, there have been 19 calls at the subject property, down from a total of 61 calls the previous month. None of these calls were nuisance-related. He has remained in regular contact with the property owner since the February 2024 meeting. A gate has been installed on the property to prevent individuals from congregating behind the property.

Detective Smith noted that when the store is closed, some individuals remain on the property. Calls made after 10 p.m. are not related to the store.

Detective Smith reported that during the past month, there have been a total of two calls, neither of which was nuisance-related.
