



## **Noise Control Advisory Committee**

### **90-day Noise Readings Summary**

**Timeline:** January 2024 – March 2024

**Number of readings:** 155

Complaint: 14

Proactive: 141

**Summary:** The data provided is the list of all noise readings taken during the 90 day study which were conducted as follows:

- Complaint – the City received a noise complaint and responded to conduct the noise reading as currently outlined in Chapter 17.
  - Residential complaints (properties not in the Special Entertainment District) – noise reading taken from the complainant’s property line.
    - After the complaint inspection, code officers conducted an additional proactive reading
  - Special Entertainment District – as outlined in the ordinance, all readings were taken five (5) feet from the from the building, structure or establishment from which the sound is emanating.
  - Number of violations from complaints during 90-day period: 2
- Proactive – all readings were taken five (5) feet from the from the building, structure, or establishment from which the sound is emanating.

#### **90-day study violation parameters:**

- Utilized a baseline dBA decibel reading of 75 (maximum dBA allowed in Chapter 17 for commercial properties (65) +10dBA as we are taking the measurements closer to the venue)
- Utilized a baseline dBC decibel reading of 85 (noise consultant concludes dBC readings are typically 10dB higher than dBAs)
- Number of violations found based on study parameters (time of reading was not a deciding factor):
  - dBA only – 22
  - dBC only – 6
  - dBA and dBC – 75
- Average of Noise Readings
  - Special Entertainment District: 82dBA and 90dBC
  - Venues outside the SED: 74dBA and 80dBC
