Thank you for your kind response.

In the interim I had the opportunity to engage in discussions with noise inspectors regarding the regulations in question. They provided insights into the intricacies of the regulations and expressed their frustrations regarding the current framework particularly in Special Entertainment zones. They acknowledged that the current regulations regarding noise measurement locations do not effectively ensure a reasonable noise level in adjacent residential zones.

Their perspective aligns with my earlier recommendation, suggesting that it would be more prudent to measure noise levels either at the complainant's property line or just outside the Special Entertainment zone, just as at the boundary with the residential zone. This approach would better ensure that the noise levels experienced by residents are in line, or lower than, those permitted in residential areas.


I hope this email answers your question and clarifies the maps I have provided.

Section 5-51 of the City of Fort Lauderdale's Unified Land Development Regulations loosely defines Special Entertainment Districts as areas designated by the City Administration and City Commission with regulations to encourage and promote the development of cultural, economic, and educational activities. These areas cater to promoting tourism and providing entertainment centers. These districts include commercial establishes with a mixture of entertainment and supporting uses including but not limited to lounges, restaurants, night clubs and other entertainment facilities, retail shops and offices. There are not entertainment districts consisting solely of residential properties. These districts are not necessarily large stretches of areas. In many instances, they are small portions of a block that encompass a business such as Rock Bar or Beach Place.

1. There are several areas and properties that fall within the City's Special Entertainment Districts. The first map in my original email highlights these areas with colors and the list below in my original email is the Map Key that identifies the name of the specific Entertainment District (i.e. Twoomey, 111 Properties, Beach Place).

I greatly appreciate your efforts in providing me with the maps and information thus far. However, I must humbly ask for further clarification, as my initial query remains unanswered.

Upon reviewing the maps you provided:

a) The first map displays an area outlined by Cortez St, S Atlantic Blvd, and Seabreeze Blvd, with a green overlay labeled as Beach Place. Regrettably, this map lacks redline boundaries or marked limits of the Special Entertainment district.

b) The second map features a red boundary encompassing a structure with blue overlay identified as Twoomey, not sure what does it is meant to represent as it is a very small area.

Thus despite these details, I still find myself uncertain about the specific streets delineating the boundaries of the Special Entertainment district containing the Rock Bar. Could you kindly shed some light on this matter?

Additionally, I am curious to know if there are (solely) residential blocks situated entirely within the confines of the Special Entertainment district(s). Your assistance in clarifying these points would be immensely appreciated.

Dear Porshia,

Thank you but I may need your help to navigate the map link you sent. Where do I search for the Special Entertainment boundaries. I navigated all options and the search engine and could not locate them.

Specifically I am inquiring about the street boundaries that form the Las Olas (against the Ocean) entertainment district, the one that reportedly includes the Rock Bar and adjacent structures.

Your help is much appreciated.

You can call me if that would be easier.

Also I circulated this weekend with my noise monitor and observed that several business such as the Elbow Room bar and restaurants next to it broadcasted sound well above 90-92 dbA in the afternoon and evening 5 feet and beyond the property line (i.e. well above the currently permissible limits). A simple "surprise" monitoring by the noise inspectors would easily confirm that non-compliance with ordinances.

I tried to call the noise reporting hotline but only got messages or no response at all. Which number is the most appropriate to call, and what are the hours of response of the noise inspectors?


