## **PUBLIC NOTICE OF** PROPOSED CONSOLIDATED PLAN AND ANNUAL ACTION PLAN AMENDMENTS

PLEASE TAKE NOTICE that the City of Fort Lauderdale (City) is considering a First (1<sup>st</sup>) amendment to its 2020-2024 Consolidated Plan and 2023-2024 Annual Action Plan. These amendments will be made in the Housing Opportunity for People with Aids/HIV (HOPWA) program in accordance with the Substantial Change Policy of the City's HUD, approved 2020-2024 Consolidated Plan.

The first amendment to the 2020-2025 Consolidated Plan and the 2023-2024 Annual Action Plan is to add and fund Sixty-Five Thousand One Hundred Seven Dollars and 47/100 (\$65,107.47) to the new 'Resource Identification' category in the HOPWA program. The funds will be allocated from uncommitted 2023-2024 grant year.

The amendment to the 2023-2024 Annual Action Plan will also allocate uncommitted funds to Mount Olive Development Corporation (MODCO), Sunshine Social Services d/b/a SunServe and Care Resource Community Health Centers d/b/a Care Resource as shown below.
